David Samm, Battle River Watershed Alliance. Mr. Samm presented Council with an overview of what the organization does and why the organization was requesting funds for projects. Mr. Samm explained that the organization was a not-for-profit organization with 15 board members made up from various industrial and academia. There is approximately 55 active members. They do 300 mail outs. Deputy Mayor Pioker asked how the Battle River Watershed Alliance's mandate fits in with the Water for Life Strategy. Mr. Samm indicated that the public needs to understand that water is not just surface water. Mr. Samm also indicated that one of the projects that the Battle River Watershed Alliance is wanting to start on is restoring of a wetland. They are currently working with the Iron Creek Watershed Group. CAO asked if Mr. Samm would like to return to the Hardisty to do a presentation to the Water Resources Committee or have an Open House, Mr. Samm indicated he would. Proposed project for 2010 is the State of the Battle River Watershed report.
