A BYLAW OF THE TOWN OF HARDISTY IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF AMENDING THE LAND USE BYLAW NO. 1139/09.

WHEREAS the Municipal Government Act, R.S.A. 2000, as amended ("the Act") authorizes the Council to establish and amend a Land Use Bylaw;

NOW THEREFORE, the Council of the Town of Hardisty, duly assembled, enacts the following:

- 1. The Land Use Bylaw of the Town of Hardisty, Bylaw No. 1139/09, is hereby amended as follows:
 - a) Section 11.0 Land Use District Map, is hereby amended by changing the Classification of part of Block Z, Plan 794 AH in the NE ¼ Section 36, TWP 42, Range 10, W4M from Urban Reserve (UR) to Single Family Residential (R1) District.

This Bylaw shall come into force and take effect upon receiving third reading.

READ a third time this 13th day of April, A.D. 2011


