TOWN OF ELK POINT #043

A BYLAW OF THE TOWN OF ELK POINT, IN THE PROVINCE OF ALBERTA, AUTHORIZING THE MUNICIPAL COUNCIL TO AMEND A MUNICIPAL BYLAW, BYLAW 671/09, BEING THE BUSINESS LICENSE BYLAW FOR THE MUNICIPAL COUNCIL OF THE TOWN OF ELK POINT.

PURSUANT to the provisions of the Municipal Government Act, being Chapter m-26 R.S.A. 2000 with amendments thereto, a Council may pass Bylaws that are considered expedient and are not contrary to this or any other Act, to establish Council and Committee procedures.

AND WHEREAS, the Municipal Council of the Town of Elk Point deems it appropriate and proper to amend the Regulations for the Business License Bylaw 671/09.

NOW THEREFORE, the Municipal Council of the Town of Elk Point, in Council assembled, enacts as follows:

- 1) Schedule "A" – Remove the phrase "your license fee is used to fund the Economic Development Committee".

This Bylaw shall take effect on the date of the final passing thereof.
