WHEREAS the Summer Village of Sundance Beach desires to enter into an agreement with the Summer Village of Silver Beach to obtain Special Constable Services within the municipal boundaries of the Summer Village of Sundance Beach; and

WHEREAS the Summer Village of Silver Beach is agreeable to such an agreement;

NOW THEREFORE, the Council of the Summer Village of Sundance Beach, duly assembled, enacts as follows:

- THAT the Summer Village of Sundance Beach enter into an agreement for the provision of Special Constable Services to the Summer Village in accordance with the Agreement attached as Schedule "A" to this By-law.
- That the Mayor and Municipal Administrator are hereby authorized to sign and execute the said Agreement with the Summer Village of Silver Beach.
