BYLAW NO. 260

A BYLAW OF THE SUMMER VILLAGE OF GOLDEN DAYS, IN THE PROVINCE OF ALBERTA, TO REPEAL CERTAIN OBSOLETE AND SUPERSEDED BYLAWS

WHEREAS, pursuant to the *Municipal Government Act*, being Chapter M-26 of the Statutes of Alberta, 2000 as amended, the power to pass a bylaw under this or any other enactment includes a power to amend or repeal a bylaw; and

WHEREAS, Council deems it appropriate to repeal certain obsolete and superseded bylaws of the Summer Village of Golden Days.

NOW THEREFORE, the Council of the Summer Village of Golden Days assembled hereby enacts as follows:

1. This Bylaw shall be known as "2018 Repeals Bylaw".
2. THAT the Bylaws as listed in Schedule "A" hereby be repealed as they have been superseded or have become obsolete.
3. THAT the repeal date of the listed Bylaws be the date of final passage of this Bylaw.
4. THAT this bylaw shall continue in full force and effect in perpetuity.
