

BYLAW 621/03

TOWN OF ELK POINT #043

A BY-LAW OF THE TOWN OF ELK POINT, IN THE PROVINCE OF ALBERTA, AUTHORIZING COUNCIL TO AMEND SCHEDULE "A" VOLUNTARY PAYMENT IN BYLAW 606/99.

Pursuant to the provisions of the Municipal Government Act being Chapter M-26 RSA 2000 and amendments thereto also the Highway Traffic Act Chapter H8 RSA 2000 and amendment thereto.

NOW THEREFORE, the Council of the Town of Elk Point, in the Province of Alberta, in session duly assembled, enacts as follows:


