

BYLAW 644/07

TOWN OF ELK POINT #043

A Bylaw of the Municipality of the Town of Elk Point, in the Province of Alberta, to amend the Land Use Bylaw, Bylaw No. 622/03.

WHEREAS the Municipal Government Act, R.S.A. ("the Act") authorizes the Council to establish and amend a Land Use Bylaw;

NOW THEREFORE, the Council of the Town of Elk Point in the Province of Alberta, duly assembled, hereby enacts as follows:

1. The Land Use Bylaw of the Town of Elk Point, Bylaw 622/03, is hereby amended as follows:
 - a. Schedule A, the Land Use District Map, is hereby amended by changing the designation of Lot 9, 10, & 11 in Block 7, Plan 6879ET and Lot 25, 26, 27, 28, & 29, in Block 7, Plan 4421MC as indicated on Schedule "A" attached hereto, from Central Commercial (C1) District to Medium Detached Residential (R2) District.
