**Schedule of Fees Bylaw**

---

**A Bylaw Of Lamont County, In The Province Of Alberta, For The Purpose Of Setting Various Fees For Services, Information, Applications Or Appeals Provided To The Public.**

**WHEREAS** the *Municipal Government Act*, R.S.A. 2000, c.M-26, (hereinafter referred to as "the Act"), as amended, provides that a municipality may pass bylaws for municipal purposes respecting services provided by the municipality;

**AND WHEREAS** the Act provides for the establishment of fees for licenses, permits and approvals by bylaw;

**AND WHEREAS** the Act provides for the provision of municipal utility services subject to the terms, costs or charges established by Council;

**AND WHEREAS** the Act provides that a municipality can provide copies of the information on payment of reasonable fees as established by bylaw.

**NOW THEREFORE** the Council of Lamont County, duly assembled, hereby enacts as follows:

1. This Bylaw shall be cited as "Schedule of Fees Bylaw."
2. That the Fees, Rates, and Charges attached hereto and forming part of this Bylaw as attached as Schedule A represents the fees, rates, and charges for 2021 applicable to the municipal services provided by Lamont County.
3. That Bylaw 813.20 is hereby repealed.
4. That this Bylaw comes into effect January 1, 2021.
