

BY - LAW # 111.  
SUMMER VILLAGE OF ITASKA BEACH  
PROVINCE OF ALBERTA

A by-law of the Summer village of Itaska Beach respecting speed limit, and parking restriction

Whereas it has been found necessary to limit the speed of traffic, and to restrict parking within the boundaries of the Summer Village of Itaska Beach;

Now, therefore, the Council of the Summer village of Itaska Beach under the authority of and subject to the provisions of Section 14 and Section 16 of the Highway Traffic Act, being Chapter H-7 of the revised Statutes of Alberta 1980, and amendments thereto, hereby enacts as follows:

1. Speed - The maximum speed limit on any highway within the boundaries of the Summer village of Itaska Beach shall be 30 kilometers per hour.
2. Parking - No motor vehicle or combination of vehicles shall park:
  - (1) In such a manner as to obstruct a private driveway.
  - (2) On the travel portion of the highway within the boundaries of the Summer Village of Itaska Beach.
  - (3) In any part of the Summer village of Itaska Beach Posted " NO PARKING".
3. Highway maintenance equipment, sewage disposal trucks, and garbage trucks are hereby exempted from Section 2 of this by-law, and emergency equipment is hereby exempted from Sections 1 & 2 of this by-law.
4. The terms "motor vehicle" and "highway shall be understood and interpreted as the same are defined by the Highway Traffic Act, being Chapter H-7 of the revised Statutes of Alberta 1980 and amendments thereto.
5. The Council hereby authorizes the issuance by the duly appointed Special Constable or Special Constables, tickets for the above Sections 1 & 2.

6. Penalties:

The penalties for violations of this by-law are as follows:

Section 1. - Speed - as set out in the Highway Traffic Act.

Section 2 - Parking:

- (1) Obstructing a private driveway a fine of \$ 20.00
- (2) On the travel portion of a highway within the boundaries of the Summer village of Itaska Beach a fine of \$ 25.00
- (3) In area posted " NO PARKING" a fine of \$ 25.00.

Vehicles contravening any of the parking provisions of this by-law for a second or more times are to be towed away at the expense of the registered owner.

By - Law # 86 is hereby rescinded.

Read a first time this 17th day of August 1983.

Read a second time this 17th day of August 1983.

Read a third time with the unanimous consent of the Council members present and finally passed this 17th day of August 1983.
