SUMMER VILLAGE OF ARGENTIA BEACH

BY-LAW NO. 128

A BY-LAW TO AUTHORIZE THE MUNICIPAL COUNCIL OF THE SUMMER VILLAGE OF ARGENTIA BEACH IN THE PROVINCE OF ALBERTA TO INCUR AN INDEBTEDNESS ON BEHALF OF THE SAID SUMMER VILLAGE OF ARGENTIA BEACH BY THE ISSUANCE OF DEBENTURES FOR THE PURPOSE OF PURCHASING LAND FOR A PARK AND MUNICIPAL RESERVE LANDS.

WHEREAS, it is deemed expedient and proper pursuant to the provisions of Section 329 of the Municipal Government Act and Section 156 of the Municipal Taxation Act that the Council shall issue a by-law to authorize the financing and acquisition of lands for park purposes; and

WHEREAS, it is estimated by the Council of the Summer Village of Argentia Beach that the total cost of the acquisition of portions of the east half of Section 13-47-1-5 consisting of approximately 120 acres is \$240,000.00; and

WHEREAS, it is estimated by the Council of the Summer Village of Argentia Beach that approximately \$40,000.00 will be paid out of the General Revenue Account of the Summer Village; and

WHEREAS, in order to complete the property acquisition project it will be necessary to borrow the sum of \$200,000.00 on the credit of the Summer Village of Argentia Beach as herein provided; and

WHEREAS, the said indebtedness is to be repaid over a period of fifteen (15) years in annual instalments, with an interest not exceeding fourteen (14)percent, or the interest rate fixed from time to time by the Alberta Municipal Financing Corporation, per annum, payable annually; and

WHEREAS, the amount of equalized assessment in the municipality as last determined and fixed by the Assessment Equalized Board is \$9,914,090; and

WHEREAS, the amount of the existing debenture debt of the Summer Village of Argentia Beach at December 31, 1993 is NIL; and

WHEREAS, the lifetime of the project is in excess of 15 years; and

WHEREAS, pursuant to the provisions of Section 156 of the Municipal Taxation Act, R.S.A., 1980, as amended, the Council of the Summer Village of Argentia Beach has received an adequate and proper petition praying for the acquisition of approximately 120 acres of land for park purposes, the costs or portion thereof to be assessed against benefiting owners in accordance with the attached Schedule "A".

NOW THEREFORE, THE MUNICIPAL COUNCIL OF THE SUMMER VILLAGE OF ARGENTIA BEACH, DULY ASSEMBLED, ENACTS AS FOLLOWS:

1. That the Municipal Council of the Summer Village of Argentia Beach is hereby empowered and authorized to enter into contracts for the purpose of acquiring such lands for park purposes as may be necessary,

- 2. That for the purpose aforesaid, the sum of Two Hundred Thousand dollars (\$200,000.00) be borrowed by way of debenture on the credit and security of the Summer Village of Argentia Beach at large, of which amount the sum of \$200,000.00 is to be collected by way of a special assessment as herein provided in attached Schedule "A".
- 3. The debentures to be issued under this by-law shall not exceed the sum of Two hundred DOLLARS (\$200,000.00), and may be in any denomination not exceeding the amount authorized by this by-law and shall be dated having regard to the date of the borrowing.
- 4. The debentures shall bear interest during the currency of the debentures, at a rate not exceeding <u>Fourter</u> per centum (<u>14%</u>), or the interest rate fixed from time to time by the Alberta Municipal Financing Corporation, per annum, payable annually.
- 5. The debentures shall be issued in such manner that the principal and interest will be combined and be made payable in, as nearly as possible, equal annual instalments over a period of FIFTEN (15) years, in accordance with the schedule attached and forming a part of each debenture.
- 6. The debentures shall be payable in lawful money of Canada at the Rayal Bank of Canada bank) in the Hamlet of Sheawar Park at such other bank or financial institution as the Council may authorize as its banking agency during the currency of the debentures.
- 7. The Mayor and Treasurer of the S.V. of Accepta Band shall authorize such bank or financial institution to make payments to the holder of the debentures, on such date and in such amounts as specified in the repayment schedule forming part of each debenture.
- 8. The said debentures shall be signed by the Mayor and the Treasurer of the S.V. of Argentia Brand the Municipal Secretary shall affix thereto the corporate seal of the said Summer Village of Argentia Beach.
- 9. There shall be levied and raised in each year of the currency of the debentures hereby authorized the amount necessary to pay the principal and interest falling due in such year on such debentures and in addition thereto the amount required to pay any of such debentures which fall due in each year after applying the special assessment hereinafter provided for, by a rate sufficient therefore on all the rateable property in the said summer of the same time and in the same manner as other rates.

- 10. During the currency of the said debentures there shall be raised annually for payment of the owners' portion of the cost and interest thereon, by special assessment under the Municipal Taxation Act, R.S.A., 1980, the respective sums shown as yearly payments on Schedule "A" (are "In") hereto attached, and there is hereby imposed on all lands fronting or abutting (or benefiting) on that portion of the streets or places whereon the said improvements are to be laid, a special assessment sufficient to cover the owners' portion of the cost of the said work and the interest thereon payable at the unit rate or rates set forth in said Schedule "A" (are "B"). The said special assessment shall be in addition to all other rates and taxes.

 11. are 12. The net amount realized by the issue and sale of debentures issued under this by-law shall be applied only for the purposes for which the indebtedness was created unless otherwise authorized by an Order of the Local Authorities Board.
- 12. ex 13. This by-law shall take effect on the day of the final passing thereof.

AND WHEREAS the Summer Village of Argentia Beach has satisfied the Board that it has complied with the requirements of Section 329 of the Municipal Government Act.

THEREFORE THE LOCAL AUTHORITIES BOARD, having read the said By-law and other material filed, HEREBY ORDERS:

- I. The issuance of debentures by the SUMMER VILLAGE OF ARGENTIA BEACH in an amount not exceeding the sum of TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) for the purpose set out above and in accordance with the provisions of said By-law No. 128 is hereby authorized.
- II. That the net amount realized from the sale of debentures issued under this Order shall be applied only for the purpose for which the indebtedness was created.
- III. That the debenture(s) to be issued under this Order may be dated upon such day as may be appropriate having regard to the date of the borrowing of the money, may be payable in fifteen (15) annual instalments of principal and interest, and may bear interest at a rate not exceeding fourteen per centum (14%), or the interest rate fixed from time to time by the Alberta Municipal Financing Corporation, per annum, payable annually.
