

LAMONT COUNTY

POLICY

- TITLE : DUST CONTROL
- AUTHORITY : PUBLIC WORKS DEPARTMENT
- POLICY STATEMENT : THE COUNTY OF LAMONT MAY PROVIDE DUST CONTROL TO ALLEVIATE HAZARDOUS CONDITIONS ON DESIGNATED GRAVEL ROADS WHICH CARRY A LARGE NUMBER OF VEHICLES
- PURPOSE : TO CONTROL DUST ON GRAVEL ROADS
- POLICY RESOLUTION : 90-201, 92-132, 93-167, 94-220, 95-174 , 97-225, 98-156, 06-59, 06-322
- PROCEDURE:
1. The County may arrange for and supply dust control annually in accordance with the following priorities:
 - a. Resource Road -Andrew North
(Farmsites Only) RR 164 North of Hwy. 45
 - b. Canexus Road -RR 202 between Hwy 15 & Twp 560
Ercos Road -RR 203 between Hwy 15 & Twp 560
 - c. Landfill Site Road -Twp 562 St. Michael West to Hwy 45 -RR
(Farmsites Only) 184 from Hwy 45 South to St. Michael -RR
184 from SH 637 South to Hwy.15
 - d. Other Locations -Seed Plant Road - RR 170 South of Hwy 15 -
Wostok Main Street Twp 563 & RR 173 - St.
Michael Railway Avenue - Twp. 562 - Star
Railway Avenue - Twp.561 & RR 193 -
Moscow Hall - Twp 520 & RR163 to Twp
520 from Highway 855 to RR 163
- Jaroslaw Hall - RR 203 and Twp 565 - Andrew
- East from Southside Service Corner
Twp. 565 to Andrew Town Limit
- East of St. Michael (yardsites) Twp 563-562 - Twp.
553 West between Hwy. 15 to SH 831 - Thiel's
Greenhouse Road - RR 203 & Twp 554 - Tagore
Estates Road -RR195 between 530 & 532 -
Strathcona/Lamont Boundary Rd
RR 204 between Hwy 15 to Twp 550
