Mayor Keeler advised that there were still some outstanding issues with the lift station in Westerose. The County of Wetaskiwin had considered implementing a \$30 waste hauling fee, but they have since waived the fee and will not be charging a fee at this time. However, it is anticipated that the County will charge the fee to County residents once the lift station is operational, and also for County residents dumping at the Mulhurst lagoon.
