DELEGATIONS

Garth and Jeanette Deacon made a presentation to Council requesting that they be permitted to landscape a portion of the Silver Beach Road allowance between their east property fence to the road surface. They provided a sketch prepared by Jon Durstling, Deer Valley Landscaping, showing the landscaping that would be undertaken. Their request included leaving in place the underground sprinkler system that they already installed.

Council thanked the Deacons for their presentation and entered into closed session to discuss their request.

Moved by Councillor Clough that the Deacon's request to landscape the area of the Silver Beach Road allowance between their property and the road surface be denied.

The Deacons are also required to immediately undertake the following:

- 1. Remove the underground sprinkler system that has been installed.
- 2. Remove the mow edge blocks that have been installed.
- 3. Level the soil and plant grass seed or install turf grass.
- 4. Plant four 4 to 5 foot spruce trees one to two metres from the east fence. *Carried.*

BUSINESS ARISING FROM PREVIOUS MEETING

1. Encroachment Agreements

The CAO informed Council that the Cochrane's have not responded to (1) the March 24, 2016 letter offering them a License of Occupation for their encroachment, or (2) the April 26, 2016 follow-up letter asking them for a response to the earlier letter.

Council directed the CAO to write to Cochranes asking for a response by May 31, 2016 to the offer of a License of Occupation for their encroachments. If Council does not hear from Cochranes by this date, it will be assumed that they reject the License of Occupation offer and the Summer Village will then give them 30 days' notice to remove their encroachments from the road allowance.

The CAO informed Council that, further to his April 26, 2016 letter to the Tallys, he had a phone conversation with Donna Tally wherein she stated they will not accept the offer of a License of Occupation and, instead, will remove their encroachments. Council directed the CAO to write to the Tallys giving them 30 days' notice to remove their encroachments from the road allowance and public land.

2. Silver Beach Road Construction

The CAO reported that Parkland Geo mailed the tender documents to contractors on the invitational list and that the closing date for submissions is Friday, May 13, 2016. Parkland Geo will provide a summary of bids received along with a recommendation for Council's consideration at the next regular meeting.
