BUSINESS ARISING FROM PREVIOUS MEETING

1. Council/Admin Tasks Review

Council reviewed the Council/Admin Tasks list and added the following items: contract with Kurt Stogrin for wastewater system inspections consultation; place sandwich boards announcing hours when spring/fall cleanup bins are available; apply for a Federal Gas Tax Fund project for culverts and drainage.

2. Mayor's Letter to County of Wetaskiwin Reeve re: Ice-Water Rescue

Council suggested some amendments to Mayor Pellatt's draft letter to the County Reeve. The Mayor will forward the revised letter to the Reeve.

2. Access to the Lakeshore Policy

Council discussed the draft Access to the Lakeshore Policy, including (1) the CAO's written policy recommendation; and (2) Councillor Miller's draft access agreements, Bylaw P30 draft amendment; and draft revision of the lakeshore policy.

Following a lengthy discussion, Council decided to withdraw the Access to the Lakeshore Policy and the CAO was directed to draft a "license of occupation" agreement and amendments to Bylaw P30 for consideration at the next Council meeting.

3. Bylaw 174-Access to Information Bylaw

Council directed the CAO to draft a policy for sharing Sundance Beach information. The CAO reported to Council that Bylaw 174-Access to Information was already in place; therefore, there is no need for a separate information sharing policy.

Council agreed and noted that Bylaw 174 should be reviewed and updated as part of the overall bylaw review project that will be implemented should the Alberta Community Partnership Grant be received.

4. Council Code of Conduct Policy

Council reviewed the letter from Alberta Municipal Affairs Deputy Minister Gary Sandberg wherein he stated that amendments to the Municipal Government Amendment Act, 2015 require councils to establish a code of conduct policy governing the conduct of councillors and to establish a public participation policy for the municipality.

Council directed the CAO to begin drafting the code of conduct and public participation policies for Sundance Beach for consideration.

5. ATB Financial Authority to Use Facsimile Signature-Business

Council discussed the ATB Financial Authority to Use Facsimile Signature-Business agreement that would allow for facsimile signatures to be used on Sundance Beach cheques or other items drawn on the summer village ATB accounts. Council decided not to use electronic signatures on cheques at this time.

6. 2017 Municipal Election Date

The CAO reported to Council that elections must be held in all Alberta municipalities in 2017, with the key dates as follows:

June/July

Nominations for the elected office in the summer village must be received by the returning officer in June or July or both June and July. Once the Nomination Day is set, the Notice of Nomination Day must be published in a local newspaper at least once a week in each of the two consecutive weeks prior to nomination day.

Election Day

In the case of summer villages, the specific day to hold the general election is not prescribed in the *Local Authorities Election Act*, and the legislation outlines the Election Day must occur four weeks after Nomination Day.

Organizational Meeting

The organizational meeting of the new council must be held no later than August 31.

Further discussion of the 2017 municipal election in Sundance Beach was tabled to the next Council meeting.

7. CRASC Panelist Approval

Council discussed the request from the Capital Region Assessment Services Commission to pass a resolution appointing the list of CRASC's panelists who are qualified to hear assessment complaints in 2017.

Council agreed that Alberta Environment and Parks could provide up to 3 signs to be installed in Sundance Beach.
