Mr. Boytinck requested to be reimbursed for the cost of the whole amount of repairs and suggested that the Summer Village needs an improved statement of liability. Council thanked Mr. Boytinck and he departed from Council Chambers at 10:29 am.

1. Local Wastewater Collection Project

Deputy Mayor Slater indicated that he has received positive feedback from residents with respect to the wastewater line installation under driveways, etc. The Ma-Me-O Days parade scheduled for this Saturday will go unimpeded by wastewater construction.

PME is the contractor chosen for the installation of the wastewater line; MPE is to provide a list of prequalified contractors for hook ups, electrical work, etc.

2. Alliance of Pigeon Lake Municipalities

Council reviewed the minutes of the APLM meeting that took place on June 14, 2017.

A public launch of the Pigeon Lake Watershed Management Plan began at the end of May on their website, along with two open houses and a public survey.

3. AUMA

The Alberta Urban Municipalities Association has drafted a resolution which could see the AUMA merging with the AAMD&C (Alberta Association of Municipal Districts & Counties). This was received as information.
