1. <u>Senior Supervisor Corey Kyle, Wetaskiwin RCMP and Cpl. Robert Gillies, Thorsby RCMP</u> Council called upon Corey Kyle, Senior Supervisor with the Wetaskiwin RCMP and Cpl. Robert Gillies of the Thorsby RCMP to commence their presentation at 10:38 am.

Senior Supervisor Kyle indicated that since the Summer Village has a population of under 5,000 people, the Summer Village would fall under the provincial policing agreement and have a minimal level of service. However, as the Summer Village of Golden Days has an enhanced policing agreement with the RCMP, the enhanced policing shifts are filled by members from Thorsby, Wetaskiwin and Breton detachments.

Senior Supervisor Kyle indicated that the Summer Village of Golden Days has 2 options for policing; currently the Summer Village is engaged with Option 2 which entails members covering shifts for \$84/hour. The other option, Option 1, is a 3-year commitment of a full-time RCMP member, with patrol car, for \$154,000/year.

Senior Supervisor Kyle indicated that the focus on the enhanced shifts has been visibility, and that residents should phone in to report suspicious activity.

Council thanked the delegation and they departed at 11:31 am.
