INSTALLATION

This agreement is to be completed and returned to the Ma Me-O Beach Summer Village Office by May 15, 2018 with payment of fees. A late fee of \$26.25 will be charged if your agreement is returned after that date.

Hoists cannot be placed more than 30 meters from shore, at a depth of more than 30" and must have 4 sides marked with yellow reflective tape or lights.

The Boat Hoist must be in the upright position, that is; the platform raised as high as it will go to be moved.

Boat Hoists must be identified with your hoist tag attached to the hoist well above the water line on the beachside of the hoist. As per Guideline #6 of policy #14-2009

If required, one positioning change will be provided after initial installation. Any additional positioning changes will be charged at a rate of \$73.50. Payment must be provided in advance for additional positioning changes.

Installation and Removal of all Boat Hoist is dependent on "Good Weather and Safe Conditions".

STORAGE

Boat Hoists may be stored for a storage fee of \$31.50 on Municipal Property with authorization from the Summer Village Office. Location dependant on Availability and Space.

Please notify the Village office if you remove your hoist to minimize time searching for it.
