In the summer of 2018, the Summer Village Council engaged Municipal Planning Services (MPS) to assist with the preparation of a new **Municipal Development Plan (MDP)**.

WHAT IS AN MDP?

An MDP is a statutory plan required for all municipalities in Alberta that identifies the future land uses within the municipality and guides future development. It provides direction regarding how development is expected to occur and how development decisions are made.

The MDP is also a comprehensive strategic document that provides municipalities with direction and guidelines on matters of social, economic and environmental importance.

The land uses identified in the MDP are general indications of future forms of development; they are not a redesignation of land use districts prescribed in the Land Use Bylaw.

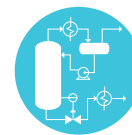

The MDP must be consistent with approved Intermunicipal Development Plans (IDPs).

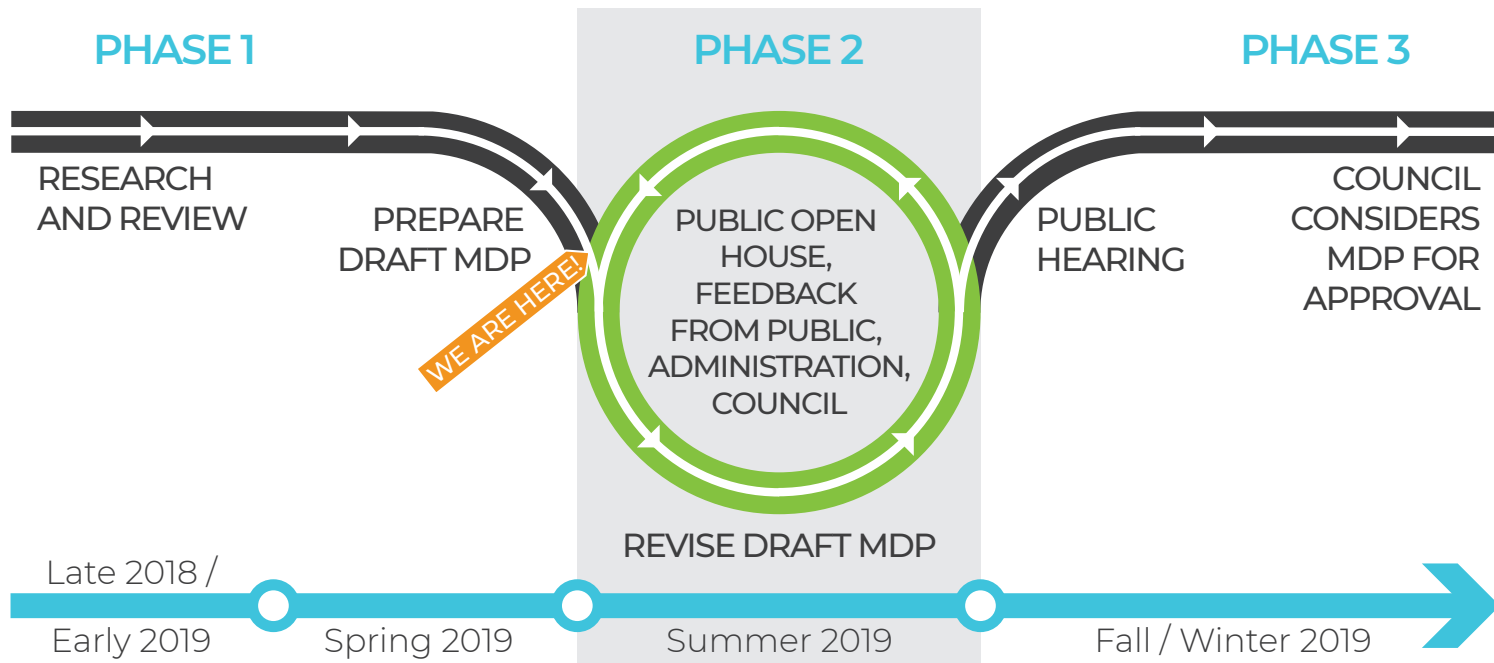

The draft plans will include watershed management planning objectives and policies from the Pigeon Lake Watershed Management Plan (PLWMP), Model Land Use Bylaw, and the Alberta Clean Runoff Action Guide where possible and strive to ensure land management practices are consistent around Pigeon Lake.
