



BOARD APPOINTMENTS - 2021

Leduc County invites county residents to apply for the following positions. A mileage and honorarium may be provided.

1) **AGRICULTURAL SERVICE BOARD**

acts in an advisory capacity to council on matters in accordance with duties, powers and functions outlined in the Agricultural Service Board Act and in support of the Weed Control Act, Soil Conservation Act, Agriculture Pests Act, Livestock Diseases Act and Water Act.

Positions available: Two (2)

- two members from the Community at Large - expiring December 31, 2022

Meeting frequency: Second Monday of the months January, March, April, June, September, November and December commencing at 10:00 a.m., or at the call of the Chair.

2) **FAMILY AND COMMUNITY SUPPORT SERVICES ADVISORY COMMITTEE**

acts in an advisory capacity to Council and to the Director of Community Services and is responsible for overseeing the development and operation of the program, and to ensure F.C.S.S. Act and Regulations are adhered to. The Committee is made up of representatives of one (1) representative of Council from each participating municipality of Calmar, Thorsby and Warburg; two (2) representatives from County Council; two (2) members at large - County residents, with one representing Rural East and the other representing Rural West.

Position available: One (1) member from Rural West

Term: Two (2) years ending December 31, 2022

Meeting Frequency: Five (5) times per year (Feb., April, June, Sept. & Nov.) commencing at 5:00 p.m.

3) **LEDUC COUNTY LIBRARY BOARD**

Manages, regulates and controls municipal library services. The committee is comprised of six members of the New Sarepta library region and two Leduc County Councillors.

Positions available: One (1)

Term: Three (3) years ending December 31, 2023

Meeting frequency: Mondays generally four (4) times per year commencing at 6:30 p.m.

Persons appointed by council will serve along with two council members.

The Library Board position is a voluntary position; no per diem or mileage will be paid.

4) **PARKS AND RECREATION ADVISORY COMMITTEE**

acts in an advisory capacity to Council.

Positions available: One (1) member

Term: Two (2) years ending December 31, 2022

Meeting frequency: Four (4) times per year on Wednesday commencing at 6:30 p.m.

Persons appointed by council will serve along with seven members of the community and two council members.

5) **PUBLIC WORKS COMMITTEE**

Purpose and responsibility shall be to deal with matters that concern policy and programs regarding activities and services within road operations, engineering and utilities (water, wastewater and solid waste/recycling) services, the establishment of service levels as key performance indicators and budget and capital plan & program review.

Positions available: Two (2)

- two members from the Community at Large - expiring December 31, 2022

Meeting frequency: Second Monday of each month commencing at 1:30 p.m., or at the call of the Chair.

6) **INTERMUNICIPAL SUBDIVISION AND DEVELOPMENT APPEAL BOARD**

This is a Quasi-Judicial Board consisting of Leduc County and the Village of Warburg residents which act independently and make decisions on subdivision, development permit and stop order appeals.

Positions available: Three (3)

Term: Three (3) year ending December 31, 2023

Meeting Frequency: Generally held on Thursday or Friday commencing at 9:00 a.m., upon receipt of an appeal.

Each member must complete the Subdivision and Development Appeal Board training in accordance with the requirements of the Municipal Government Act and Subdivision and Development Appeal Board Regulations.
