#### **DELEGATIONS AND VISITORS**

Mrs. Joan Brown, Ma-Me-O Beach Resident

At 10:08 am Council welcomed Mrs. Joan Brown. Mrs. Brown relayed her concerns regarding contravention of the Ma-Me-O Beach Land Use Bylaw relating to the long-term parking/use of recreational vehicles on residential lots, as well as the use of vehicles and off highway vehicles on the beach and in the water. Council thanked Mrs. Brown and she departed from Council Chambers at 10:16 am.

#### Mr. Doug Bell, Pigeon Lake Watershed Association

At 10:28 am Council welcomed Mr. Doug Bell of the Pigeon Lake Watershed Association (PLWA). Mr. Bell spoke of the PLWA's projects including the environmental law centre research and reports, Integrated Watershed Management Plan, site consultations and shoreline cleanup and asked Council to consider a financial contribution to assist with PLWA administration and projects.

Ma-Me-O Recreation Society

Councillor Langelle indicated that the schedule of events and activities for 2011 has been developed, and it will be posted on the Ma-Me-O Beach website. Summer staff are in place and the Society is running smoothly.
