

SCHEDULE "A" BYLAW 2009/13

WATER SERVICE RATES

The following water service charges shall be levied and collected bi-monthly from all persons, businesses, churches, clubs and charitable organizations, government units, etc. connected to the Town of Millet water system;

SINGLE FAMILY DWELLING UNITS;

2013

-\$28.80 for the first 15 cubic meters and **1.40** for each additional cubic meter of water thereafter.

2014

-\$36.00 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

2015

-\$50.40 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

COMMERCIAL AND INDUSTRIAL UNITS;

2013

-\$36.00 for the first 15 cubic meters and **1.40** for each additional cubic meter of water thereafter.

2014

-\$42.40 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

2015

-\$59.36 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

PUBLIC AND INSTITUTIONAL SCHOOLS;

2013

-\$36.00 for the first 15 cubic meters and **1.40** for each additional cubic meter of water thereafter.

2014

-\$45.00 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

2015

-\$63.00 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

CHURCHES, CLUBS, ASSOCIATIONS, CHARITABLE ORGANIZATIONS;

2013 - \$28.80 for the first 15 cubic meters and **1.40** for each additional cubic meter of water thereafter.

2014 - \$28.80 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

2015 - \$28.80 for the first 15 cubic meters and **2.00** for each additional cubic meter of water thereafter.

ALL OTHER SERVICES BY AGREEMENT OF COUNCIL.

ADDITIONAL FEES

Disconnection Fee: \$25

Reconnection Fee: \$25

Transfer arrears from Utility to tax roll administration fee \$25

Flat Rate for all mobile home units and damaged meters –

2013 - \$60.80/billing period

2014 - \$76.00/billing period

2015 – \$90.00/billing period

PENALTIES:

A (3.9%) percent penalty shall be added to the outstanding current balance if payment is not received at the Town office on the date indicated on each bill.

SCHEDULE "B" BYLAW 2009/13

SEWER SERVICE CHARGES

The following sewer service charges shall be levied monthly from all persons, business, churches, clubs, charitable organizations, government units, etc., connected to the Town of Millet sanitary sewer system.

These charges shall be collected by the Town on a bi-monthly basis.

The monthly charge shall be as follows:

RESIDENTIAL

Single family dwelling units and Apartments, Condominiums, Duplexes, etc.

2013 - \$15.70 per month

2014 - \$16.20 per month

2015 - \$16.80 per month

COMMERCIAL

Car Wash

2013 - \$41.00 per month per stall

2014 - \$42.00 per month per stall

2015 - \$44.00 per month per stall

All other commercial businesses

2013 - \$20.40 per month

2014 - \$21.00 per month

2015 - \$22.00 per month

****PLUS 50% of the amount charged over and above the flat rate for water consumption pursuant to Schedule "A" of third bylaw, for COMMERCIAL users only.

PUBLIC AND INSTITUTIONAL

School

2013 - \$92.00 per month

2014 - \$94.00 per month

2015 - \$97.00 per month

Churches, Clubs, Associations, Charitable Organizations

2013 - \$15.70 per month

2014 - \$16.20 per month

2015 - \$16.80 per month
