1. Association of Pigeon Lake Municipalities

Council reviewed the agenda for the APLM Meeting scheduled for November 19th. Mayor Kay will be attending this meeting.

2. Joint Services Committee

Council reviewed the minutes of the Joint Services Committee held on October 23, 2013. Items discussed included the tax payment deadline, the posting of development permit applications on the website and the purchase of a tailgate spreader for winter traction.

Moved by Councillor Tooke that the Summer Village of Golden Days enter into the shared purchase of the tailgate spreader for \$150.

3. Capital Region Assessment Services Commission

Deputy Mayor Belmont provided a brief overview of the CRASC Annual General Meeting held on November 13, 2013.

Board members were elected; the individual representing Summer Villages is Doug Thomas, Mayor of the Summer Village of Seba Beach. There will be an increase in our annual fees by \$.25 per parcel for the 2014 year (\$17.50 per parcel). Residents are encouraged to speak to the assessor and examine the tax roll prior to filing an appeal.

4. Encroachment Agreement - A18 Golden Days

Moved by Deputy Mayor Belmont to rescind Res. #13-103 as approved at the Council Meeting of October 21, 2013.

Res. # 13-114

Moved by Mayor Kay to enter into an encroachment agreement with the current owners of A18 Golden Days for a fence, light posts and concrete approach that encroaches onto municipal road right of way, for a fee of \$500, with taxes to be charged annually for the encroachment onto the municipal road right of way.

Grounds for approval of this encroachment is that it doesn't affect health of the lake, and that the road drains directly into a ditch that drains directly into the lake.

It was noted that property taxes will be charged to the resident for his encroachment, similar to what the City of Edmonton does with their encroachments.

5. Resident Email: Remembering Don Schell

Council reviewed an email that was sent from Ms. Laura Murphy (nee Schell), indicating that her father and mother were both involved with Summer Village of Golden Days municipal affairs, her father serving as Mayor and her mother serving as the Secretary, for many years. Her father, Mr. Don Schell, recently passed away and Ms. Murphy was hoping that the memory of her family's commitment to Golden Days could be memorialized by way of the naming (or renaming) of a street in Golden Days, similar to Ellen Toth Way.

A response will be sent to Ms. Murphy indicating that Don is fondly remembered, and that Council will see what appropriate projects are planned for the future to see if an opportunity exists for a naming prospect.

6. Insurance

Deputy Mayor Belmont advised that through a meeting with a member of Administration, she learned that the Golden Days insurance deductible was decreased and is not in favour of this reduction.
